As Idaho Falls School District 91 plans for the coming school year, **we are focused on opening schools, operating as close to normal as possible, closing learning gaps and working together with parents, patrons and staff to ensure our students are successful and gain the knowledge, skills and attributes they need to be successful beyond high school.**

D91's Going Back To School Plan 2021-22 considers input received from parents, patrons, students and staff over the last year. How D91 Will Respond To Confirmed Cases of COVID-19:

An important part of limiting the spread of COVID-19 in our schools and community is following the health guidance, identifying those who may be sick or infected and working together to keep the virus in check.

Student Confirmed Cases:

If D91 receives notice of a confirmed and documented student case:

- Principal will report the case to the assistant superintendent of elementary or secondary education and review any unique circumstances.
- Principal will conduct contact tracing with teachers and staff as necessary in accordance with most recent guidance.
- Principal will contact impacted students/staff and, if necessary, notify them of the need to quarantine. Decisions about quarantine will be made in accordance with the latest guidance.
 - No quarantine necessary if both parties are wearing masks correctly
 - No quarantine if fully vaccinated and not showing symptoms, but individual should be tested 3 to 5 days after exposure and wear a mask indoors for 14 days or until they receive a negative test
 - Without masks, students/staff would need to isolate for 10 days from the last date of contact or 7 days with a negative COVID-19 test
- Principal will notify parents and the school community about confirmed cases.
- D91 will report the number of confirmed student cases district wide.
- Infection rates at individual schools will be monitored. If infection rates indicate the need for a school closure, any closures would be temporary to allow for additional cleaning and/or for individuals to recover.

Staff Confirmed Cases:

If a staff member tests positive for COVID-19:

- The staff member should immediately notify their supervisor and HR.
- The staff member should follow quarantine guidance from their doctor or Eastern Idaho Public Health.
- Staff who are isolating, but cannot perform their assigned duties by telecommuting would need to take leave. HR can provide information on leave options, which could include:
 - Personal sick or vacation time
 - A leave of absence
- Staff member should assist with contact tracing to help identify students and staff who may be impacted.
- D91 will report the number of confirmed staff cases district wide as necessary.
- Infection rates at individual schools will be monitored. If infection rates indicate the need for a school closure, any closures would be temporary to allow for additional cleaning and/or for individuals to recover.
